#### 02 — Skills

·Do I have the skills to operate this business?



#### 03 — Knowledge

How well do I know my product/service, and is there a market for my product/service?

#### 04 — Competition

What is the competition like for this product/service?



#### 05 — Business Plan

Do I have a written business plan?

#### 06 — Funding

Do I have adequate funding to operate my business?

### SUGGESTED STEPS TO OPENING A BUSINESS

- 1. Make an appointment with the Virginia Small Business Development Center for free consulting, affordable training courses, personal referrals to local resources, guidance, insights, and connections to help your business succeed. Learn more about Wise County's SBDC located at Mountain Empire Community college (https://www.mecc.edu/sbdc/).
- 2. Write your business plan. This process is will help you think through all the details and is required for most funding requests. There are many templates available for free on the internet.
- 3. Get an accountant or accounting software.
- 4. Your business structure affects how much you pay in taxes, your ability to raise money, the paperwork you need to file, and your personal liability. You'll need to choose a business structure before you register your business with the state. An attorney or a tax professional can help you determine the best type of business structure (Sole proprietorship, general partnership, Limited liability partnership etc.)

Once you know your structure type, get your Federal & State Tax ID/EIN A Federal Employer Identification Number (EIN), is like a social security number for a business and allows you to open bank accounts, handle payroll, and file taxes. An EIN is needed by any business that retains employees. However, non-employers are also required to obtain one if they operate as a corporation or partnership.

### SUGGESTED STEPS TO OPENING A BUSINESS

5. Find a location of your business. We are a multi-county town. It is very important to know which county you are in prior to applying for a license.

6. If you are building, changing use of a building or renovating a business, please check the zoning ordinances which can be found at: https://www.wisecounty.org/169/Zoning-Ordinance

Contact the Wise County Building & Zoning Department concerning zoning requirements. Their website has easy to find information on when a building permit is required. https://wisecounty.org/h162/Building-Zoning

- Register Your Business Entity: Once you've come up with your business concept, completed your research, developed a plan, and secured funding if needed, it's time to register with the Commonwealth of Virginia State Corporation Commission. https://www.scc.virginia.gov/pages/New-Business-Resources
- · Check name availability
- Reserve a name
- Form a business

In some cases, you don't need to register at all. If you conduct business as yourself using your legal name, you won't need to register.



When you start a business in a rural town, you become part of a greater community. You build connections and friendships over time. A sense of collaboration, a desire to support local businesses and pride in the community strengthens everyone's will to succeed.

Local Business Licenses: To conduct business in the Town of St. Paul you must have a business license and be in compliance with the zoning ordinance. A business wishing to locate in a permitted zoning district without the need for development can obtain the necessary compliance permit quickly and easily by visiting Town Hall.

Town Hall is open Monday through Friday 8:30am to 4:30pm to issue a business license to operate a business and set up commercial waste service. The cost of a business license per year is based on revenue/gross receipts (see chart below).

There is a \$30 business license minimum. The minimum license covers the first \$18,000 of gross receipts.

- ·Existing Businesses Filing deadline is February 28th based on the previous year's gross receipts.

Water/Sewer Hook-up and Payment: The cost of commercial waste collection services varies based on the frequency of collection. You may set up services while applying for your business license. A photo ID and SSN is required to begin services

### SUGGESTED STEPS TO OPENING A BUSINESS

8. Fire Prevention Inspections: If renovating or purchasing a building, a Wise County Fire Inspector will conduct a fire inspection prior to opening. This service is free of charge and can be scheduled prior to opening by calling the Wise County Fire Department

#### Restaurants/Retail

- Restaurants and retail stores selling alcohol must contact the Virginia Alcohol Beverage Commission.
